We may carry out checks against publicly available records and credit records using an electronic authentication system. Details of your credit history will not be made available to us. The data providers may add the details of the searches to their records, but credit scoring agencies will not use the records of the Bank's search in their scoring of future credit applications.

If you have access to the Power of Attorney document online, we're able to accept an LPA Access Code in place of the original/certified document. You can request an LPA Access code on your online account on the Government website. This should be a 13 character code starting with a V.

Please be aware that in some circumstances we may need to view the physical Power of Attorney document (for example, where you don't have a digital access code). We reserve the right to request an original or certified copy of the document to proceed with the registration of the Attorney(s).

You can post the original or certified documentation to us at Freepost VIDA SAVINGS.

This is a freepost address, there is no need for a stamp. Please be aware that when you're sending original documents to us, this is done so at your own risk. Certified copies of documents are recommended and preferred.

Once we've successfully registered the attorney(s) for your Vida Savings account(s), we'll contact you with further details explaining how you can access the account(s) online and through our mobile app.

Please note

- The Account Holder will be responsible for the attorney(s) actions or omissions as if they were their own.
- We'll only accept attorney(s) appointed to act on a single signature basis.
- By appointing the attorney(s) to operate the account, the Account Holder will be unable to do so.
- We'll assume that it is intended to appoint the attorney(s) to operate all of the Account Holder's accounts with us. If this is not the case and you wish to limit the appointment to only some of the Account Holder's accounts, then you need to tell us when submitting your application.
- This appointment will revoke the appointment of any attorney(s) currently appointed to operate the account(s), unless they have been appointed under the same Power of Attorney.
- The Nominated Account, which must be used to transfer funds (including interest) into and out of the account(s) held with us, will not change as a result of appointing an attorney to operate the account. - Any notices or correspondence sent by post will be sent to the mailing address for the first attorney.
